The Priority Dispatch quote provided to the Authority was only good through December 2020. As the Authority is not prepared to purchase the software in 2020, confirmation of quote for 2021 indicated an approximate 10% cost increase.

Dispatch Operations Report

Mandi Schlensker reported one dispatcher tested positive for COVID19 so is quarantined for two weeks. No one else was required to quarantine

EMD certification is due for four dispatchers. The cost is \$50/dispatcher. She has ordered tests to be mailed and asks that the Authority pays for recertification.

There were issues with Language Line but they have been resolved. eForce is researching tow rotation which hasn't worked for year, since dispatched moved to the 1st Street location. Charles Glorioso stated that internet service is the issue and is being rectified. Mandi has been asking users of the eForce system if they are satisfied with the product. She reports that "no one" likes it

A change in agenda sequence occurred when Spellman Systems scheduled a Go To Meeting event to overview their CAD product.

Miscellaneous

Spillman Flex CAD system overview. Shaun Cavanaugh a Spillman representative presented an extensive overview of the CAD system. A few aspects are that it is a modular system, Call Works integrated, configurable for each dispatcher, and offers software for Jail. It does populate emergency reporting which would provide information to the fire ERS system. ProQA, a separate, third party software, which integrates with Spillman provides incident specific dispatcher questions except for medical. (Priority Dispatch has moduler for all first responders). Questions arose concerning data storage. Spillman provides on- premises server storage but is working on Cloud-based storage.

Unfinished Business

Intellichoice Invoice. Although the annual invoice from Intellichoice/eForce was approved at the September meeting, the check was held until confirmation that the Las Animas County District Attorney's office paid \$1,450 covering service for the RMS licenses they use. A new invoice has been issued showing that payment has been received so the Authority will send its payment.

Dixon-Waller Exit Interview. Barbara Fisk spoke with the representative at Dixon-Waller who conducts the yearly audit for the Authority. He stated that an exit interview has never been done for the Authority. He pointed out that smaller entities, such as the Authority, never get an exit interview.

Dispatcher Re-certification. The board discussed paying for the EMD recertifications of dispatchers. It was clarified that none of the money set aside for training in the 2020 budget has been spent. Mandi confirmed with Charles Glorioso that the City Police Department budget would cover the cost if the board did not.

Motion to pay for four dispatcher's EMD recertification at \$50.00 per dispatcher (\$200.00) using funds from line item 878.1 Training/Continuing Education of the 2020 budget was made by David Bacharach.
