### **CLARIFICATION NEEDED**

### **RESPONSE DEADLINE: NOVEMBER 12, 2021**

At the November 4th Authority meeting, the board voted to purchase 2 consolettes for the redundant center in 2021. The only stipulation was that neither consolette was to be encrypted. Walt Garbo just called and stated that ONE of the consolettes will contain the following channels:

Main Channel = **PD Tac (encrypted)** and

Secondary Channels = MAC 12, County Road and Bridge and Local Government.

This is not what the board voted for. There are a few options.

Please **REPLY TO ALL** when responding with your choice.

### **OPTION 1**

Install the consolette but do not encrypt the PD Tac channel. PD would then have the ability to encrypt the channel as desired because they own the channel.

### **OPTION 2**

Take the channel out completely. PD would have one less channel at the Redundant Center.

### **OPTION 3**

Have the Redundant Center match completely to the Primary Center - same configuration including encryption.


