Dispatch Assessment Jaci Marie Louise of 911 Solutions conducted a Las Animas County ETSA 911

Center Assessment including both the main and redundant dispatch centers. participated in this meeting via teleconference to answer any questions the board may

have. She highlighted the following information:

Concern about the phone system capacity, at the time of the assessment, and

Mandi was working on installation of the Rapid SOS.

The board asked if she was aware of CAD systems that would integrate with the current eForce RMS that the police department uses. She concurred that eForce has a very good RMS system and that there are several different CAD systems that would integrate. Concerns were raised about using Motorola for yet another operating system. She stated that, if the board were to go with Motorola, the contract should specifically state eForce RMS will integrate. She also suggested that Motorola may offer a better deal since their system is already in use. Jaci also volunteered to research Requests For Information from a few different providers for the board which they accepted.
