Dispatch Report Mandi Schlensker, Communications Director stated that eForce issues continue e.g.

notes listed backward, deleting names and addresses, ProQA not working with eForce. Money has been sent to Joe Richards as County Emergency Manager for IPAWS.

There are several new applicants for dispatch positions.

Unfinished Business eForce CAD Retention. Dave Bacharach and Darren Kolakowski voiced frustration

over continuation of eForce topic. It was stated that Dispatch had a choice of a new

CAD system or consoles and they chose consoles and it is believed the Authority

doesn't have the money to fund both. Also reiterated was the fact that law enforcement is concerned about losing information out of their Records Management Systems if CAD is switched to another provider. Mandi Schlensker noted that dispatch continues to drop calls and her contact for fixing issues isn't getting the job done. She stated that no one within Dispatch is happy with eForce.

TOPIC TABLED TO BUDGET PREPARATION.

Motorola Consoles Budgetary Proposal. Consoles are to be installed at the Primary Dispatch Center, 160 E. 1st Street, Trinidad. Walt Garbo and Peter Jorjorian, both attending as Motorola Reps., were present to answer any questions the Authority may have about the final Budgetary Proposal which consists of 5 years at 5.73%. The proposal consists of \$100k down to be applied to maintenance with the remainder financed. Dave Bacharach voiced concern about the fact that Ed Boyer, with the State, was sent the proposal for review to ensure the Authority isn't paying for unneeded equipment and has not responded. When Walt Garbo stated he had spoken with Ed Boyer, Dave Bacharach continued to voice concern about the State communicating with Motorola not the Authority. During the meeting, Walt Garbo called Ed Boyer but his representative stated he was very busy with the big upgrade and working closely with Motorola. The representative will reach out to Ed Boyer.

FCC licensing for the microwave, frequency coordination at Bowen Hill will be necessary. Walt Garbo will reach out to the Authority with more information.

Motion was made by Darren Kolakowski to approved purchase of two consoles for the Primary Dispatch Center at 160 E. 1st Street, Trinidad by way of a five year 5.73% interest lease agreement with Motorola.
