## **SUBJECT DISCUSSION**

Call to Order/Pledge Meeting was called to order at 1:32pm by Chairperson Gabriel Moreno followed by

the recitation of the Pledge of Allegiance.

Roll Call There was *not* a quorum with four (4) board members in attendance.

Public Comments The meeting, along with the budget hearing following, was announced on lac911.com

wherein the public was directed to contact Barbara Fisk with requests to participate in

the Public Comments section of this meeting. NO requests were received.

Approval of Minutes One amendment was requested to the July 2024 meeting minutes. Under Dispatch

Report, paragraph 2, sentence 2 Sound Off should be ESO. The amendment has been

made.

Financial Report

The July 2024 Financial Statement was provided by Bernadette Cappellucci with the following statement, "Cash in the bank totaled \$746,009.75 as of July 31, 2024. Revenues collected in July were \$44,664.75. Total expenses for the month of July were \$20,107.74 resulting in a net income of \$24,634.54 for the month and a net income of \$123,238.27 for the year as of July 31, 2024."

It was noted that James Baker's name still appears on the IN Bank Statement which will be changed.

The July 2024 Financial Statement will be added to the September 2024 agenda for approval.

Dispatch Report

Mandi Schlensker, Communications Director continues, unsuccessfully, to interview dispatch applicants. It was asked if non-emergent calls could by handled by AI or if Huerfano County could share calls. Clarification on the application for Voyager AI was requested.

eForce has not corrected any of the issues submitted. It was suggested the Board research Central Square and Oracle to provide CAD services. Different ideas were discussed for obtaining the help of a grant writer to help cover costs for a new CAD system. Reference was made to an email dated August 22, 2024 from Mandi Schlensker to Chuck Price about unresolved eForce issues (attached).

RAVE will be tested on September 12<sup>th</sup>. The City will distribute sign up fliers to all utility customers but San Isabel will not. County residents will have to rely on

newspaper and radio for information. RAVE interfaces with IPAWS. What percentage of the use of RAVE is the City? Should the City be required to pay some of the cost?
