Dispatch Report

Communications Director Mandi Schlensker was out sick so Interim Police Chief Mike Tihonovich informed the Board that new dispatcher is in training.

Las Animas County Emergency Manager Joe Richards voice concern that IPAWS is not up and running. Previously Mandi stated she needs to get certified through an online course. Joe Richards brought his copies of certification, gave them to Mike Tihonovich to give to Mandi to use for IPAWS credentials.

The have been recent issues with RAVE paging departments not pertinent to calls. This will need correction before IPAWS will work properly.

Unfinished Business CAD Options. Mike Tihonovich provided information about four options to replace eForce.

- 1. Ztron has provided a quote.
- 2. Central Square is performing a demonstration next week.
- 3. Motorola rep provided a quote which is half the cost of previous quote.

Once all three quotes are received they will be presented to the Board.

Motorola Radio Console System. The MCC7500E radio console system, including microwave have been received. A virtual kickoff meeting set for today, Thursday, March 27th at 3pm. Motorola's Regional Manager Mike McQueen is waiting for access to Bowan Hill regarding microwave installation. Walt Gabro laid out the process for complete installation for which an approximate date of late May - early June was noted.

- 1. Install and commission microwaves at Bowen Hill and Trinidad Police Department.
- 2. Motorola will conduct 24 hr tests on each link to Pueblo (Site 6).
- 3. Installation
 - a. Move dispatch operations to the redundant station,
 - b. Install, configure and test at TPD site,
 - c. Training,
 - d. Cut operations over to TPD site.

Dave Bacharach voiced concern over use of Orange Pancake (Emergency) Button It will work with radio reconfiguration. If pressed, the channel will automatically switch to a predesignated channel. Each department will establish those numbers prior to reconfiguration. If radios are capable, GPS is available. New console has up to 160 channels for use.

New Business

Gabriel Moreno explained the history behind his draft letter to the Joint Budget Committee. The letter opposes the proposal in the FY 2025-26 Staff Figure Setting Document to use the newly created 9-1-1 Services Enterprise Fund to cover a \$12 million shortfall in funding the state's Digital Trunked Radio System (DTS). He asked Jaci Marie Louis of 911 Solutions to review the letter. She agreed with its content but suggested postponing sending it until she has an opportunity to get back Las Animas County Emergency Telephone Service Authority Regular Meeting March 27, 2025

with him. Upon further discussion, the Board also agreed with its continent and sending once notified by Jaci Marie Louis. He also informed the Board about the following Legislative Committee notes.
